



**INVITATION TO BID FOR THE SUBSCRIPTION OF
INTERNET LEASED LINE
(6 MBPS DEDICATED FOR INTERNET CONNECTION ON-LINE
PDOS PORTAL / PDOS ON-LINE PROGRAM AND
10 MBPS FOR SECONDARY INTERNET SOURCE)**

1. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, through the **2017 Corporate Budget**, intends to apply the sum of **One Million One Hundred Forty Thousand Pesos (Php1,140,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for **Bidding for the Subscription of Internet Leased Line (6 MBPS Dedicated Internet Connection on On-Line PDOS Portal/PDOS On-Line Program and 10 MBPS for Secondary Internet Source)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **OWWA** now invites bids for **Bidding for the Subscription of Internet Leased Line (6 MBPS Dedicated Internet Connection on On-Line PDOS Portal/PDOS On-Line Program and 10 MBPS for Secondary Internet Source)**. Delivery of the Services is required on **01 August 2017**. Bidders should have completed, within the **last Two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **OWWA BAC Secretariat** and inspect the Bidding Documents at the address given below during 8:00am to 5:00pm from Monday to Friday.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **30 June 2017** from the address above and upon payment of the applicable fee for the Bidding Documents in the amount of **One Thousand Pesos (Php1,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **OWWA** will hold a **Pre-Bid Conference** on **July 7, 2017, 10:00 am** at the **Conference Room, 10th Floor, OWWA Center, 7th Street cor. F.B. Harrison Street, Pasay City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **July 19, 2017, 10:00 am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **July 19, 2017, 10:00 am** at the **Conference Room, 10th Floor, OWWA Center, 7th Street cor. F.B. Harrison Street, Pasay City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **OWWA** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
